Crashes are 4-times more likely to happen at night, and many fatalities can be avoided with careful planning and responsible drinking.

You can help make roadways safer and ensure that you can enjoy the festivities without incurring a DUI or endangering others by planning ahead this holiday season:

If you are going to drink, entrust your keys to the host of the event or other responsible person as soon as you get there. This can be a designated driver, a close coworker, or a relative. Be sure to select this person ahead of time and discuss this strategy with them.

Keep a list of nearby cab companies in your wallet or saved on your smartphone. Dial 1-800-TAXI-USA for immediate taxi service or download the company's free mobile app, Taximobile, to find a taxi service near you. If you are intoxicated and need a ride home, consider using a service like Lyft or Uber. The popular ride-sharing applications cost about as much as one drink per ride and keep your hands off the wheel.

Avoid driving late at night. Crashes are 4-times more likely to occur after dark during the holidays. The safest way to avoid incidents on the road is to plan your drive times around routine congestion and road conditions. Remember there is no stigma attached to deciding not to drink at a holiday social gathering. Take on the role of a designated driver for someone else, and try some of that holiday punch!

As the host of a get-together this season, you are integral in helping to prevent drunk driving and DUI incidents. If you serve alcoholic beverages, be sure to also serve plenty of food, as a full stomach helps alcohol absorb more slowly into the bloodstream. Provide tasty alcohol-free alternatives to alcoholic beverages so that designated drivers won't feel left out or be tempted to indulge. Pay attention to your guests' behavior and serve alcohol accordingly. It's usually smart to stop serving alcoholic drinks an hour or two before the party ends.

### Ground turkey meatballs mixed with celery, onions, and combread stuffing mix. Thanksgiving in a bowl!

Prep Time: 5 mins • Cook Time: 20 mins • Total Time: 25 mins Servings: 4 Ingredients

- 1 lb lean ground turkey (I used 96%)
- 2 cups cornbread stuffing mix, lightly crushed
- 1 celery stalk, diced
- 1 small yellow onion, finely diced
- 2 cloves minced garlic
- 2 eggs
  - 2 tbsp chopped fresh parsley
- 1/2 cup low sodium chicken broth
  - Salt and pepper, to taste


Instructions:

- 1 Preheat oven to 400 F and spray a baking sheet with non-stick spray.
- **2** Place cornbread mix in a large bag and gently crush with hands or a rolling pin. You want the stuffing to act as the breadcrumb in these meatballs, so you want that consistency rather than huge chunks of stuffing.
- **3** Combine all ingredients in a large bowl and mix. Using your hands or a large kitchen scoop, form meatballs and place about an inch apart on baking sheet.
- 4 Spray meatballs with olive oil cooking spray and bake for 20 minutes. This recipe yields about 20 meatballs
  - **5** Serve and enjoy!

## The Norfolk Mermaids have graced the streets and buildings of Norfolk for well over a decade.



### Bringing an Idea to Life

In 1999, Pete Decker, Jr. (1936-2012) introduced the idea of mermaids at Nauticus during a breakfast with 300 Norfolk leaders. The concept is attributed to his wife, Bess, who had recently returned from Chicago and suggested Norfolk do something similar to the Windy City's "Cows on Parade" art exhibit.

Mermaids were picked to represent Norfolk's nautical heritage, and the idea took off from there. Within a few months, local bronze sculptors mass-produced 130 life-size mermaid castings, and talented artists from all over Norfolk were commissioned to bring the castings to life.

`The decorated mermaids—all different and special with their own quirky personalities—were then auctioned off at the event "Mermaids on Parade" in November, 2000. The beautiful sculptures were placed outside hospitals, schools, community organizations, and countless other Norfolk establishments and homes.

### A Symbol of Norfolk Pride

Since then, many more mermaids have been added to the family, and they have become a recognizable symbol of our city. Norfolk natives carry the mermaid symbol with them wherever they go. Whether they wear it as a necklace, a t-shirt, or simply a warm memory, the Norfolk mermaid has traveled the world.

Representing happiness, bringing us beauty, and always welcoming us home, today, the mermaid is more than a logo for the city. It's a symbol of Norfolk pride.

lifting weights. This keeps him healthy and helps him focus on his cases for the day. He believes it's important to be in the best physical condition to fight for his clients.

The attorney has a great deal of compassion for others, perhaps because of a very serious event surrounding his first child. Jack was 17 weeks in utero when it was discovered by EVMS Maternal Fetal Medicine that he had transposition of the great arteries, or D-TGA. This condition is caused when the two major arteries leaving the heart are connected to the wrong ventricles. It was a stressful time for the young couple. Twelve days after birth, Jack had a surgery known as the switch operation at Levine Children's Hospital in Charlotte

to correct the problem. Today, Jack has a functionally normal heart and is an energetic toddler, but would have died without the surgery. Jeff remembers when people stepped in to help his family, and this fuels him to passionately represent each and every client.

"I'm an advocate for the injured because I know what it's like to have to deal with a very serious frightening situation," Jeff declares.

Paralegal Lisa Lechner aids Jeff in pursuing justice. She joined The Decker Law Firm in May, and brought with her a vast array of experience.
